

REGULATION ADDENDUM

Thyssen Krupp Elite Challenge 2025

Updated: May 19th, 2025

SECTION 3. RIGHTS AND CONDITIONS OF PARTICIPATION

The competition is open to all Blachotrapez dealers from Romania, Hungary, and Bulgaria who meet the following conditions:

- Are official Blachotrapez partners at the time of registration.
- Operate within the territory of the three mentioned countries.
- Commercialize eligible Thyssen Krupp materials for the competition: metal tiles, trapezoidal sheets, or panel materials TK such as IceCrystal TK, Mat TK, or **Cristal AM** (starting May 19th, 2025).

Participation in the competition implies full acceptance of the present regulation.

SECTION 4. COMPETITION MECHANISM

The score calculation is based on the total square meters of eligible materials sold during the competition period.

Starting **May 19th, 2025**, **Cristal AM** is added to the list of eligible materials considered for score calculation.

All other conditions and competition terms remain unchanged, including the competition period: **January 15th, 2025 – August 15th, 2025**.

This document is an integral part of the official competition regulation and enters into effect on **May 19th, 2025**.

CONTEST REGULATION

“Thyssen Krupp Elite Challenge”

SECTION 1. ORGANIZER OF THE CONTEST

The organizer of the “Thyssen Krupp Elite Challenge 2025” contest (hereinafter referred to as "the Contest") is S.C. BLACHOTRAPEZ S.R.L., headquartered in Baia Mare, Str. Fabricii nr. 8A, 430015, Maramureş County, registered with the Maramureş Trade Register under no. J24/162/2010, unique identification code RO 26610878, with account RO24 BACX 0000 0004 6455 5001 opened at Unicredit Bank, represented by Jaroslaw Turczynski, General Manager.

The contest is conducted according to the provisions of this Regulation, which is mandatory for all participants. The organizer reserves the right to modify or change the regulation, with the obligation to notify the public in the same manner in which the initial information was communicated.

SECTION 2. PLACE AND DURATION OF THE CONTEST

The contest takes place from January 15, 2025, to August 15, 2025, and is addressed to Blachotrapez dealers in Romania, Hungary, and Bulgaria.

SECTION 3. RIGHTS AND CONDITIONS OF PARTICIPATION

The contest organized by Blachotrapez S.R.L. is open to individuals who have reached the age of 18 at the time of registration. The contest is accessible to all legal entities, Blachotrapez partners, regardless of domicile, race, gender, or religion, who meet the conditions of this regulation and follow the instructions stated herein to validate their participation.

Participation in this contest constitutes full acceptance, freely given, of the provisions of this Regulation.

The contest is open to all Blachotrapez dealers from Romania, Hungary, and Bulgaria who meet the following conditions:

1. Are official Blachotrapez partners at the time of registration.
2. Operate within the territories of the three mentioned countries.
3. Sell eligible Thyssen Krupp materials for the contest: metal tiles, trapezoidal sheets, or panels made of IceCrystal TK or Mat TK materials (flat sheets and accessories are excluded).

By registering for the contest, participants confirm they have read, understood, and accepted the terms and conditions of this Regulation.

Participants are entitled to be evaluated fairly, under the same conditions, and according to the same criteria as all other competitors. They are required to comply with the participation conditions and the official decisions of the organizers.

Participants must provide accurate information in all required registration fields. By registering for the contest, participants confirm they have read and understood the provisions above.

The right to participate in the contest is automatically annulled in case of any violation of the provisions of the regulation, without the organizer being obliged to justify its decision.

The organizer reserves the right to reject any registration if it:

- Does not comply with the contest theme;
- Contains any form of violence;
- Promotes any kind of discrimination;
- Is offensive, abusive, indecent, defamatory, or obscene;
- May harm a person, business, or entity;
- Is protected by copyrights not belonging to the participant;
- Contains advertising materials other than those of BLACHOTRAPEZ SRL.

SECTION 4. CONTEST MECHANISM

The registration period for participants starts on January 15, 2025 and ends on August 15, 2025. Participants registered before or after the registration period will not be eligible.

Steps to participate:

1. The participant accesses the contest page on the Blachotrapez website:
<https://contest.blacho.ro>.
2. Enters the correct information required by the Organizer.
3. Receives a validation email for registration and account activation from the organizer.
4. Each participant's ranking will be communicated individually via email, with periodic updates sent by the organizer.
5. The organizer will notify the winners using the contact information provided during registration and will also announce them on the official Thyssen Krupp Elite Challenge 2025 contest page after the contest ends.

Registration period: Dealers can register for the contest starting January 15, 2025, by completing the online form available on the official Blachotrapez page.

Scoring calculation: Based on the total square meters of eligible materials sold during the contest period, starting from the participant's registration on the contest website and validation by operators.

Exclusions: Flat sheets and accessories are not included in the sales volume calculation.

Leaderboard: The top 15 dealers will be ranked based on sales volume, updated periodically. Rankings will be established according to the square meters (m²) of Thyssen Krupp metal roofing materials sold. The organizer will send notifications and interim rankings via email.

SECTION 5. CONTEST PRIZES

The prize consists of a 7-night vacation for 2 people at the Titanic Deluxe Golf Belek hotel, located in Belek, Turkey, a 5-star hotel offering an ultra all-inclusive experience.

The vacation will take place from September 20 – 27, 2025, and includes:

1. Transportation:
 - Charter flight round trip on the Cluj-Napoca – Antalya – Cluj-Napoca route.
 - Transfers from the airport to the hotel and back, with climate-controlled transportation.
2. Accommodation:
 - Standard rooms for winners:
 - Double and single rooms (based on winners, as agreed with the organizer).
 - Ultra all-inclusive regime, with all meals and drinks included.
3. Additional services:
 - Travel insurance (Travel-Basic) provided by ERGO Reiseversicherung.
 - All taxes and mandatory contributions (including Tourism Fund) are covered.

A total of 15 prizes will be awarded, each representing a complete trip for 2 people, with a total combined value of up to 390,000 RON.

SECTION 6. WINNER SELECTION

Winners will be determined based on final scores calculated and validated by an internal committee. The conditions for winner validation are as follows:

1. The participant must meet all the requirements of this regulation.
2. The participant must respond to the Organizer's requests within 3 business days of notification.
3. If confirmation is not provided within the specified timeframe, the prize will be reallocated to the next participant in the ranking.

Winner announcement:

- Winners will be notified via email using the contact information provided during registration.
- The final list of winners will be published on the official Thyssen Krupp Elite Challenge 2025 contest page and communicated via email.

Fraud or rule violations: The organizer reserves the right to invalidate the participation of a winner if irregularities or violations of the regulation are detected. The committee's decision is final and cannot be contested.

SECTION 7. CONTEST PROMOTION

The contest will be promoted through the following channels:

 - Flyers and posters distributed at Blachotrapez partner locations.

The organizer reserves the right to use other promotional channels if deemed effective for increasing contest visibility.

SECTION 8. OTHER PROVISIONS

1. Publication of the regulation: The complete regulation will be available on the official contest website and can be consulted by any interested person.

2. Changes to the regulation: The organizer reserves the right to modify this regulation, provided that changes are communicated publicly using the same channels through which the initial regulation was announced.
 3. Responsibilities: The organizer is not responsible for any errors in the data provided by participants or for any technical issues that may occur during the contest.
 4. Personal data: By participating in the contest, participants agree to the processing of personal data in accordance with applicable legislation. The data will be used exclusively for the purpose of organizing and conducting the contest.
 5. Disputes: Any disputes related to this contest will be resolved amicably. If an amicable resolution is not possible, the dispute will be settled by the competent courts in Baia Mare, Romania.

COMPETITION MECHANISM</p> <p>Starting on August 05, 2025, the following provision shall apply:</p> <p>“During the period from August 05, 2025 to August 15, 2025, all orders for Estima metal tile, regardless of the requested raw material, will earn double points in the ranking.</p> <p>Thus, when calculating the score, a factor of 2 will be applied to the quantity expressed in square meters for this model.”</p> <p>All other conditions and deadlines of the competition remain unchanged, including the duration: January 15, 2025 – August 15, 2025.</p> <p>This document is an integral part of the official regulations and shall enter into force on August 05, 2025.</p> <p>Organizer: S.C.
